## Innovation Leader

EIT Digital seeks to generate significant digital 'deep tech' innovations from top European research results. Each innovation activity gathers EIT Digital partners to bring promising mature research results out of the lab and quickly into the market. The objective is to create drive digital innovation and transformation through the creation of startups and the launch of Minimal Viable Products (MVP).

Our investments are focused on a number of strategic areas: **Digital Tech**, **Digital Industry**, **Digital Cities**, **Digital Wellbeing** and **Digital Finance**. These areas have been selected based on their relevance for Europe and their potential to establish European leadership.

The Innovation Leaders drive the total portfolio of EIT Digital innovation activities which is made up of activities in the above areas.

The Innovation Leader has a proactive opportunity-driven business attitude combined with a deep digital technology intimacy. He or she has the skills to combine contribution to the vision with effective and hands-on execution of the operation. Being successful in the job requires acting as a team player with strong verbal and written communication skills in English.

## Key Responsibilities

The key responsibilities of the Innovation Leaders are to create an innovation activity portfolio with the following key objectives:

1. High impact: assure that innovation activities are strategic and have a right to win at a global level.
2. Value creation: in terms of startup creation or product launch as an outcome of the innovation activities.
3. Return on Investment: assure that activities contribute to EIT Digital financial sustainability through generation of income.
4. Education integration: engage and coach EIT Digital students within innovation activities by defining internships, post-master topics, Summer School and PhD topics.

The Innovation Leaders act as a team where each member is responsible for part of the overall portfolio for which they are expected to execute the annual cycle while assuring that delivery and objectives are achieved. The annual cycle includes:

- a. Call preparation: support the launch of the EIT Digital annual call for proposal to feed the Digital Innovation Factory.
- b. Proposal submission: support partners in preparing and submitting strong proposals.
- c. Proposal selection: participate in the selection of the proposals.
- d. Business Plan construction: provide input to the EIT Digital Business Plan, that will include selected proposals.
- e. Activity execution: manage and orchestrate innovation activities within the portfolio.
- f. Activity delivery: drive activities to deliver on operational milestones, KPIs, as well as setting them for customer and investor success by the end of the activity.
- g. Reporting: perform timely and thorough reporting in the context of EIT Digital processes.
